Items for Action

Approve Minutes for November 19, 2025

A motion was made by John Boeder, seconded by Jerry Nash to approve the FP14 Student Attendance Agreement of a YA Student to EG. Motion passed unanimously.

PEAK (Pathways to elevate Attendance and Knowledge) – Montana Safe Schools Center MOU

Supt. Tresch stated PEAK contacted him asking for YA to allow PEAK to run a Focus Group at YA. The Focus Group centers on school attendance. Determining factors to school attendance such as voluntary attendance, emotional and cultural barriers and school culture.

John Boeder motioned to approve the MOU with PEAK. Second to the motion was Jerry Nash. Motion passed unanimously.
